SUMMARY:

- Optimize the handling of bank and deposit relationships and initiate appropriate strategies to enhance cash position.

- Be an advisor from the financial perspective on any contracts into which the Corporation may enter.
- Evaluation of the finance division and accounting structure and team plan for continual improvement of the efficiency and effectiveness of the group as well as providing individuals with professional and personal growth with emphasis on opportunities (where possible) of individuals.
